To Whom It May Concern:

Arc Hennepin-Carver is an organization that for over 57 years has been providing advocacy and support on behalf of children and adults with mental retardation and related developmental disabilities, and their families. The comprehensive nature of providing these services does not occur without dedicated collaborating partners within the community. One such partner is AMAS, Inc. directed by Mr. Deen Ajibola.
